Reports were received from the Treasurer and the Editor.

An invitation was received from the Muséum National d'Histoire Naturelle in Paris for delegates to attend the tercentenary celebrations of the Museum from 24 to 29 June. It was resolved to ask the Foreign Secretary to represent the Society.

GENERAL MEETING.

Held in the Apartments of the Geological Society, Burlington House, London, W., January 24, 1935, at 5.30 p.m.

Sir THOMAS H. HOLLAND, F.R.S., President, in the Chair.

Thirty-seven Members and five Visitors were present.

Sir THOMAS H. HOLLAND, F.R.S., President, in the Chair.

Prof. Edward Battersby Bailey, Mr. William Burton, Mr. William Colin Campbell Rose, and Mr. John Herbert Stanley were provisionally elected Ordinary Members of the Society. The resignation of Mr. Gilbert Greenwood was accepted.

A letter was received from Dr. A. E. Fersman thanking the Society for having elected him an Honorary Member.

Reports were received from the Treasurer and the Editor.

Owing to the illness of the Foreign Secretary, Mr. Arthur Russell and Dr. G. F. Herbert Smith were appointed as the Society's delegates at the tercentenary celebrations of the Muséum National d'Histoire Naturelle in Paris in June.

It was agreed to circulate to members the recommendations of the Nomenclature Committee and hold a discussion on the proposals at the next General Meeting.

Forty-three Members and six Visitors were present.

The elections of Prof. E. B. Bailey, Mr. W. Burton, Mr. W. C. C. Rose, and Mr. J. H. Stanley as Ordinary Members of the Society were confirmed.

The death of Dr. Herbert H. Thomas on May 12, 1935, was announced, and it was decided to send a letter of sympathy to Mrs. Thomas from the Society.

Reports were received from the Treasurer and the Editor. The Editor read a letter from Sir Henry Miers and remarked that Sir Henry had been most helpful to him, having carefully read all proofs of the Magazine since 1900. The Secretary was instructed to send the thanks of the Society to Sir Henry.

The list of Officers and Members of Council for 1935-6 was considered, and it was decided that the four senior Ordinary Members should retire, namely, Prof. P. G. H. Boswell, Prof. H. L. Bowman, Dr. L. Hawkes, and Mr. J. B. Scrivenor. A further vacancy caused by the death of Dr. H. H. Thomas had also to be filled. Mr. Arthur Russell, Vice-President since 1932, was also due to retire from that office. The following were proposed for submission to the Members : as Vice-President, Prof. P. G. H. Boswell; as Ordinary Members of Council, Mr. A. Broughton Edge, Prof. H. H. Read, Mr. Arthur Russell, Mr. R. C. Spiller, and Dr. Gilbert Wilson.

The address to the Muséum National d'Histoire Naturelle in Paris on the occasion of its tercentenary was read and approved. Mr. Arthur Russell announced that he would not be able to go to Paris as one of the Society's delegates on this occasion.

Dr. A. E. H. Tutton was appointed as the Society's delegate at the opening of the new building of the Geological Survey and Museum and at the celebration of the centenary of the Survey on July 3.

GENERAL MEETING.

Held in the Apartments of the Geological Society, Burlington House, London, W., June 6, 1935, at 5.30 p.m.

Sir THOMAS H. HOLLAND, F.R.S., President, in the Chair.

Forty Members and three Visitors were present.

The elections of Mrs. Virginia Courtauld, Mr. A. C. D. Pain, and Mr. W. Hugill as Ordinary Members of the Society were confirmed.

The following exhibits were explained :---

1. Stalactites and 'straw' stalactites from Winsor Hill quarry, Shepton Mallet, Somerset, and cut specimens of silica-glass from the Libyan Desert : exhibited by Dr. L. J. Spencer.

2. Gem-stones cut from Devonshire fluorite, zinc-blende, and cassiterite: exhibited by Mr. E. P. Bottley.

Dr. L. J. Spencer opened a discussion on mineralogical nomenclature, in the course of which the General Secretary outlined the course of discussions carried on with the Mineralogical Society of America, and other members of the Society expressed their opinions on Dr. Spencer's proposals. No definite conclusion was arrived at.

The suggestions made in 1924 for international agreement in mineralogical and crystallographical nomenclature (Min. Mag., vol. 20, pp. 353-363) have not been realized, and it is now desirable to attempt to arrive at national agreement, and if possible for all English-speaking countries. Dr. Gordon Frank Claringbull, Mr. Henry Stantley Lawies Jackson, and the Rev. Arthur Frederick Smethurst were provisionally elected Ordinary Members of the Society.

Reports were received from the Treasurer and the Editor.

Mr. T. Crook and Dr. W. R. Jones were appointed auditors for the accounts.

The draft Annual Report was read and after amendment approved. It was decided to hold the meetings in 1936 on Thursdays, January 30, March 26, June 25, and November 5.

GENERAL (ANNIVERSARY) MEETING.

Held in the Apartments of the Geological Society, Burlington House, London, W., November 14, 1935, at 5.30 p.m.

Sir THOMAS H. HOLLAND, F.R.S., President, in the Chair.

Thirty-seven Members and seven Visitors were present.

The chairman nominated Dr. Malcolm MacGregor and Mr. C. F. Davidson to act as scrutineers of the voting-papers for the election of Officers and Council.

The elections of Dr. G. F. Claringbull, Mr. H. S. L. Jackson, and the Rev. A. F. Smethurst as Ordinary Members of the Society were confirmed.

The General Secretary then read the following :---

ANNUAL REPORT OF COUNCIL FOR 1934-1935.

During the session 1934-5 there have been four ordinary meetings and nineteen papers have been read. Brief abstracts of papers to be read have been circulated to members before the meetings instead of the card giving titles only, and special exhibits of specimens have been on view at each meeting. The total attendance at the four meetings was 169.

At the meeting in June a discussion on mineralogical nomenclature was opened by Dr. L. J. Spencer, who advocated agreement among the English-speaking countries, and proceeded to give a selected list of names as at present adopted in the Mineralogical Magazine for minerals having two or more current alternative names. His list was as follows :—Analcime, anatase, baryte, blende (zincblende), chalcopyrite, chalcosine, chalybite, chessylite, cordierite, felspar, fibrolite, fluorite, haematite, halite, hemimorphite, idocrase, kyanite, mispickel, nepheline, olivine, phenakite, pyrite, pyrrhotine, scapolite, smithsonite, sphene, stibnite, uraninite. The General Secretary outlined the course of discussions carried on chiefly by correspondence with the committee of the Mineralogical Society of America, and various members expressed their opinions of Dr. Spencer's proposals. Many members in particular preferred azurite to chessylite, chalcocite to chalcosine, siderite to chalybite, pyrrhotite to pyrrhotine, arsenopyrite to mispickel, and sillimanite to fibrolite.

The Council regrets to record the deaths of one Honorary Member, Professor Edward Salisbury Dana, and of four Ordinary Members: James Broadhead; Francis Henry Butler, a Life Member since 1885; James Malcolm Maclaren: and Herbert Henry Thomas, a past Vice-President, and for fourteen years a member of the Council.

Three Ordinary Members have resigned. One Honorary Member, Dr. A. E. Fersman, and ten Ordinary Members have been elected, bringing the total membership on October 31, 1935, to 236, including eight Honorary Members.

During the year there have been issued four numbers of the Magazine (nos. 147-150), containing 17 papers occupying 180 pages, with 36 pages of proceedings, bye-laws, and list of members, 22 text figures, and 5 plates. Mineralogical Abstracts published with these numbers occupied 144 pages, containing 499 abstracts. Number 147 of the Magazine consisted of the index to volume 23 of the Magazine and volume 5 of the Abstracts, containing about 12,000 entries and occupying 118 pages. This was compiled by the Editor, Dr. L. J. Spencer.

The accounts for the year ending December 31, 1934, showed an excess of assets over liabilities of £1247 10s. 4d. against £1151 12s. 11d. on December 30, 1933. These assets do not include the Library and unsold stock of publications, nor the securities allocated to the Composition Fees Account. The value of the securities standing in the names of the Trustees on December 31, 1934, was, General Reserve £990 0s. 8d., Composition Fees Account £1081 12s. 7d., against £874 14s. 3d. and £987 3s. 9d., respectively, on December 30, 1933. During the year £50 8s. 0d. Metropolitan Water Board 3% 'B' Stock, inscribed, was purchased for addition to the General Reserve, and £10 12s. 0d. of that stock and £10 4s. 8d. 3% Conversion Loan 1948/53 inscribed Stock for the Composition Fees Account.

The Society's Library has received during the year 125 parts of periodicals, and 15 separate copies of papers. 35 parts or volumes have been borrowed.

At the invitation of Professor C. E. Tilley members of the Society paid a visit to the new laboratories of the Department of Mineralogy and Petrology at Cambridge on Saturday, June 15. There were present Sir John S. Flett and Dr. A. E. H. Tutton, past-Presidents, sixteen members, and eight guests. Parties were conducted through the laboratories and the museum by members of the staff of the Department, and demonstrations were given, particularly of apparatus used in the measurement of physical properties and for the construction of crystal models. The visitors were entertained to tea by the Professor and Mrs. Tilley. A vote of thanks proposed by Dr. Tutton was passed with an enthusiasm indicative of the interesting afternoon which all enjoyed.

Dr. G. F. Herbert Smith acted as the Society's delegate at the tercentenary celebrations of the Muséum National d'Histoire Naturelle in Paris, and presented an address from the Society. Dr. A. E. H. Tutton represented the Society at the celebration of the centenary of the Geological Survey of Great Britain and at the opening of the new building of the Geological Survey and Museum.

The adoption of the report having been proposed from the Chair and seconded by Prof. C. G. Cullis was carried unanimously. A vote of thanks to the Geological Society for allowing the use of its apartments was proposed by Mr. R. C. Spiller and seconded by Mr. E. P. Bottley and carried unanimously.

The scrutineers reported that 58 voting-papers for the Officers and Council for the ensuing year had been received and that the list nominated by the Council had been approved. The President declared these Officers and Ordinary Members of Council elected :---
